What is the LaunchBoard

Chancellor's Office's **suite** of web-based data **dashboards** that bring education, employment, and some labor market information together to **measure progress** on the **Vision Goals** and **aid decision making** and **planning** in postsecondary institutions by displaying **lagging indicators**.



Dashboards in the LaunchBoard

Strong Workforce Program Dashboard—displays data for CTE students on all CTE programs, industry sectors and individual programs (using the six-digit Taxonomy of Program code).

Student Success Metrics Dashboard—showcases student progression along various educational journeys, from recruitment to completion, transfer and the workforce.

Community College Pipeline—is the most comprehensive dashboard, offering views of students at the industry sector and program level.

Guided Pathways Dashboard—provides a cohort view of first-time students' progress with first-year momentum points for evaluating college redesign efforts

Adult Education Pipeline—displays data for K-12 adult education and community college noncredit student journeys including progress, transition, completion and workforce outcomes.







Purpose and Background of SWP Dashboard

- The main purpose of the dashboard is to view key CTE student outcome metrics used in the 17% SWP Incentive Funding at the program, sector, college, regional or statewide level
- Created in 2016 with the passage of legislation
- **Major redesign** of the User Interface in 2019 to synchronize look and feel with other LaunchBoard accountability dashboards
- Includes data on non-special admit credit and noncredit CTE students who meet minimum enrollment requirements (.05 credit units or 12+ contact hours in noncredit)
- Now aligns to metrics in Student Success Metrics dashboard



Some Key features of SWP

- The SWP accountability metrics are the basically the same as those in other CO initiatives and dashboards: Student Success, Vision Goals and the Student Centered Funding Formula
- The same "All CTE Programs" can be viewed on the Community College Pipeline to get even more information about how those students are being served
- Drill down on any metric by Demographics or by Perkins Economically Disadvantaged
- Limited number of metrics
- Ability to **benchmark** at different locale levels and **compare**



SWP Funding Formula: More and Better CTE




Strong Workforce Program Funding Model



Strong Workforce Program Funding Formula

Both the Strong Workforce Program base and incentive funding are re-calculated each year according to the factors prescribed in legislation:

Factors		Proportion of SWP Funds
	Unemployment Rate	1/3
Base Funding	Career Education FTES	1/3
	Job Openings	1/6
Incentive Funding	SWP Metrics	1/6





17% SWP Incentive Funding Points Calculations

Metrics	Points Awarded		
9+ CTE Units, Noncredit Workforce Milestone	½ point will be awarded per student who attains the outcome		
	1 point: CO-approved credit certificate of 8 to < 16 units or noncredit certificate of 48 to < 288 hours		
Credential Attainment	2 points: Credit certificate of 16 to < 30 units or noncredit certificate of at least 288 hours		
Attainment	3 points: Credit certificate of at least 30 units, associate degree		
	4 points: CCC bachelor's degree or apprenticeship journey status		
Transfer, Earnings Gains & Living Wage	2 points are awarded for each student who attains the outcome		
Job Closely Related to Field of Study	Points calculation: % of students who report employment in a job closely related to their field of study, multiplied by the # of students who were sent the survey		
Median Earnings	Points calculation: 1 point is awarded for each dollar earned, then the number is divided by forty to make the figure proportional to other measures		



Weighting for Economically Disadvantaged Students (EDS and Non-EDS)

Most metrics	EDS will receive points worth twice what non-EDS receive
Job closely related to field of study metric	Not applicable
Median earnings metric	



Incentive Funding Calculations Local Share

- Points for all CTE programs at all community colleges are totaled to **create a statewide sum**.
- This sum is divided by the amount of local funding available per FY for the 17% local share to **create a value per point**.
- The value per point is multiplied by the number of points that each college received to determine its distribution.

Multi-college districts: the distributions for **all district's colleges are summed** to create the district distribution.



Incentive Funding Calculations *Regional Share*

- Points for all CTE programs are totaled at the regional level and added together to **create a statewide sum**.
- This sum is divided by the amount of regional funding available per FY for the 17% regional share to **create a value per point**.
- The value per point is multiplied by the number of points that each region received to determine its distribution.

Regions: the distributions for **all region's colleges are summed** to create the regional distribution.





From the <u>CTE Outcomes Survey FAQ on website</u>, the CTE cohort for the CTEOS is defined as follows:

- 1. Received a CO approved CTE award and enrolled in 0-5 units each semester the following year OR
- 2. Received a CTE award of at least 6 units that is not CO approved and are not enrolled the following year OR
- 3. Have completed 9 units that are SAM coded A-D, with at least one course SAM coded A-C (within the prior 3 years), have not received a CTE award of 6 or more units, and are not enrolled the following year





SWP Students Who Earned 9 or More Career Education Units in the District in a Single Year




There is only one successful completion metric displayed on the SWP dashboard while students are counted in the highest completion category for the 17% SWP funding just like the SCFF calculation. Also, metric outcomes achieved by EDS students are doubled for the 17% SWP calculations.



SWP Students with a Job Closely Related to Their Field of Study




Job in Field of Study is displayed as a % on the SWP dashboard. The % is multiplied by the no. of CTE students attempted to survey which is not displayed on the SWP dashboard. Metric outcomes achieved by EDS students are not doubled for 17%.

Median Annual Earnings for SWP Exiting Students




Median annual earnings metric is displayed as a dollar figure on the SWP dashboard. The dollar figure is translated to points and then divided by 40 to make the weighting of the metric proportional to other metrics. Metric outcomes achieved by EDS students are not doubled for 17%.

Median Change in Earnings for SWP Exiting Students




Median % change in earnings is displayed as a percentage on the SWP dashboard while the 17% SWP Incentive Funding allocation counts the number of students who had a wage gain which is not displayed on the dashboard. Also, metric outcomes achieved by EDS students are doubled for the 17% SWP calculations

SWP Exiting Students Who Attained the Living Wage



Attained the living wage is displayed as a percentage on the SWP dashboard while the 17% SWP Incentive Funding allocation uses the numerator displayed in the hover over or the count of students who attained the living wage. Also, metric outcomes achieved by EDS students are doubled for the 17% SWP calculations
