



LaunchBoard Updates for 2022-23

June 29, 2023

This document describes improvements and features updates that have been made as part of the LaunchBoard dashboards 2023 releases. In addition to the items listed below, all dashboards are being updated to incorporate 2021-22 enrollment and completion data; 2020-21 transfer, employment, and earnings data; and 2019-20 Career and Technical Education Outcomes Survey (CTEOS) data where appropriate.

STRONG WORKFORCE DASHBOARD

The Strong Workforce Program dashboard, which focuses on CTE students, displays metrics included in the 17% Strong Workforce Program (SWP) Incentive Allocation aligned with Student Success Metrics for colleges, for districts and for regions. This dashboard displays data for all CTE programs, industry sectors and individual programs (using the four-digit and six-digit Taxonomy of Program codes).

As part of the June 2023 release, the only changes that have been made to metrics are for alignment with other LaunchBoard dashboards. These changes are outlined in the Changes in Definitions document available on the dashboard.

K12 STRONG WORKFORCE DASHBOARD

The K12 Strong Workforce Program dashboard examines Career Technical Education (CTE) engagement and high school graduation for K12 students at institutions awarded K12 SWP funding. The second release in February 2023 release added in data successfully submitted through Cal-PASS Plus at the institution level by Local Education Agencies (LEAs), determined to have been grantees in Rounds 1, 2, and 3 of K12 SWP funding, including two additional years of data for school years 2020-21 and 2021-22. Three additional metrics for K12 Transition and a comparison view were also added as part of the release. The data only refresh in June 2023 adds in additional data submitted after the earlier 2023 release for the existing four years included in the dashboard.

STUDENT SUCCESS METRICS DASHBOARD

The Student Success Metrics dashboard showcases student progression along various educational journeys, from recruitment to completion, transfer, and the workforce. The metrics provide a holistic approach to student success across funding streams and initiatives and can support colleges in setting goals that align with the Vision for Success.

As part of the Spring 2023 release, a new metric and a new cohort length has been added to the cohort view. Successfully completed 30 units in their first year has been added as a Guided Pathways first year momentum metric. A two-year cohort length has been added as well in addition to the other three-, four-, six-year cohort timeframes.

Additionally, several improvements have been made to the User Interface, and resources have been updated. Any updates or changes are outlined in the Changes in Definitions document available on the dashboard.

ADULT EDUCATION PIPELINE DASHBOARD

The Adult Education Pipeline displays data for K-12 adult education and community college noncredit adult education students including progress, transition, completion, and employment outcomes. K-12 data from CASAS TOPSpro Enterprise and noncredit data from the Chancellor's Office Management Information System is integrated to display a comprehensive picture of California Adult Education Program measures and outcomes. Practitioners can view many metrics by program area, including English as a Second Language (ESL), Adult Basic Education (ABE), Adult Secondary Education (ASE) and Career and Technical Education (CTE).

As part of the Spring 2023 release, the program type drilldown has been added to an additional metric, new adult education institutions reporting into TOPSpro have been added to the dashboard, a select number of coding updates have been made, and resources have been updated.
